Transformation Generative Linguistics emerged throughout the second half of the twentieth century. It focuses on Noam Chomsky's concept of cognitive development. This notion holds that everyone is born with the ability to learn a language. During the early phases of language acquisition, children encounter language rules and become conscious of their inherent understanding of the language. They gradually become aware of their ability to form a variety of statements.

Modern Approach

The above-defined methods can be used in schools, but the responsibility of improving English speaking is not only up to schools.
